BUILDERS COUNCIL - WED JUNE 10

The next Builders Council meeting is Wednesday, June 10 at 12 noon via Zoom.

Colin Dumais from Radon West will do a presentation on the latest findings re: radon. Colin tests homes and discovered foundation dimple wrap, intended to draw moisture away from footings, has the unintended consequence of increasing radon in

homes by causing high slab pressure. While the BC govt claims the Victoria region and the lower mainland are low radon zones, high levels of radon have been found in Duncan, Salt Spring Island and the North Shore in Vancouver. Every home has some level of radon and high levels are often site specific. Studies show new, very energy efficient homes draw in more radon unless there is mitigation.

BUILDERS COUNCIL - GLASS SHORTAGE & HERITAGE CONSERVATION ACT

Anton Van Dyk, Vice President of Sales and Business Development, Centra Construction Group provided an excellent discussion at Builders Council on the glass shortage. This is the result of housing demand and the shortage exists despite glass manufacturers increasing their production significantly. Anton recommends contacting your supplier well-in-advance to acquire windows. In fact, the same could be said for many products.

The second part of Builders Council was a presentation by Heather Chia, Manager, Policy and Engagement and Eric Forgeng, Supervisor of Permitting from BC's Archaeology Branch. They provided an overview of the Heritage Conservation Act as it applies to home building including local government and builder responsibilities. It is clear some municipalities such as Saanich are creating a backlog and costly process for identifying archaeological sites. VRBA is working with the branch to achieve a solution.

DECONSTRUCTING HOMES BACKGROUNDER

The City of Victoria plans to enact a bylaw requiring the deconstruction of older homes only for single detached and townhome projects – already the most expensive housing. VRBA wrote a letter to council suggesting the city support programs such as Built Green and track the already extensive recycling efforts by builders. We also suggested the city offer a permit discount based on builders' invoices from recycling companies. This is a simple and effective solution suggested by VRBA's builder members. The city's own report admits there is a single deconstruction company, which would create a bottleneck, and an additional eight skilled workers would be required to complete the task over weeks.

City staff estimated a cost of \$30,000, however there have been costs up to \$300,000. In addition, many old materials would not be reusable, including those that do not meet the building code and those with asbestos.

We received a single response to our letter prior to the council meeting from Councilor Geoff Young, who agreed with us and opposed council's motion due to the lack of effectiveness, added time and cost.

The City of Victoria did not publish our letter with their council agenda and report, preventing transparency and the public receiving our opinion. Subsequently, the city put out a news release promoting their plan, much of what was covered in a cut and paste style by some news media.

However, credit goes to the Times Colonist and CFAX1070 for their diligence checking with VRBA to get our view.
