#### WORKSAFEBC CONSULTATION ON WORKPLACE STATUS CLOSES DECEMBER 15

WorkSafeBC is proposing changes to workplace status and whether someone is an employer, worker, or independent operator. We have concerns regarding their consultation paper, which says on page 15:

"Under the proposed policies, it is anticipated the removal of labour contractor policy would result in more individuals being found to be workers rather than being able to register as independent operators or employers with WorkSafeBC. As a result, premiums may rise for employers who contract with labour contractors who have POP, as some of these individuals would instead be determined to be workers on their payroll. This shift from POP coverage to employer premiums would likely have the biggest impact in sectors where there are more labour contractors."

The consultation closes on December 15, 2021. We will be submitting our comments after consultation with VRBA's Builders Council.
